Aims

It is the overall aim of Date Palm Primary School to minimise the risks to pupils, staff and employees which may arise from fire. This will be done by ensuring procedures are in place for minimising the effects of an outbreak of fire and evacuating the premises.

Overall Responsibility for Fire Safety Matters

The Head teacher has overall responsibility for fire safety matters at the school. She will coordinate the implementation of fire safety measures, ensure that staff and pupil training takes place and monitor the standard of fire precautions maintained. She will also ensure that a fire evacuation drill is undertaken each term, that fire action notices are kept up to date and that fire safety equipment is being maintained. The School Fire Procedure Notices displaying the school fire procedure will be displayed at each fire alarm call point.

Appointment and Duties of Fire Marshals

The school will appoint a number of teaching or administrative staff as fire marshals one of which will be appointed as a senior fire marshal. These staff will have responsibility for ensuring that all areas of the school have been evacuated and that this is reported to the senior fire marshal in charge of the evacuation.

Staff

All school staff are responsible for maintaining a high standard of fire precautions in areas under their control or influence. In particular, staff should ensure that they are fully aware of the fire procedure. They should ensure that door vision panels and fire exits are kept clear



and fire doors are kept shut. They should also ensure that pupils for whom they are responsible are informed of the fire procedure.

Fire Training and Evacuation Drills

Training will be provided during induction for all staff and volunteers in fire safety and the school fire procedure. Specific training is organised for Fire Marshals, including training in the practical use of fire extinguishers, both on appointment and at least every three years with an external Fire Safety training provider. Feedback on fire drills is provided termly to all staff members.

PEEP

Children with Special Educational Needs and Disability will have a Personal Emergency Evacuation Plan (PEEP) to help them evacuate safely from the building. Currently three children at the Greenfield branch have a PEEP. The SENDCo reviews this annually and if required during the year.
